

ILLINOIS POLLUTION CONTROL BOARD
MINUTES OF REGULAR BOARD MEETING
JUNE 12, 1980, CHICAGO, ILLINOIS

All Board Members were present.

An Opinion and Order was adopted in #79-5, Crossroads, by a vote of 4-0. Mr. Werner abstained.

An Order was adopted in #78-239 and #79-96, SCM, by a vote of 5-0.

Opinions and Orders were adopted in these cases by a vote of 5-0: #79-214, Ogle County View, Mr. Dumelle and Mr. Goodman concurred; 79-220, Village of Thornton; 80-15, Environmental Site Developers, Mr. Werner concurred; 80-18, Amoco Chemical; 80-44, Riverton, Order only; 80-61, Department of Energy; 80-92, Allied Chemical.

An Order was adopted in R74-2, R75-5, Sulfur Dioxide, by a vote of 4-1. Mr. Werner dissented.

In #80-70, Rolling Meadows and #80-58, Willowbrook, the Board ordered that hearings be held as expeditiously as possible. The Board noted that the time for decisions in these matters would run before the next scheduled meeting and that a special meeting would be scheduled to decide the matters.

Motion for reconsideration in #79-77, Randolph County Landfill, was denied by a vote of 4-1, Mr. Werner dissented. Mr. Dumelle will prepare an Order.

Motion to quash and dismiss was denied in #79-55, Chevy Chase, by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to reconsider prior Board Order was granted in #79-141, Outboard Marine. Motion to modify was then denied and a motion by intervenor was referred to the Hearing Officer. The vote was 5-0 and Mr. Goodman will prepare an Order.

An Order was adopted on a petition filed in #79-153, Amak, by a vote of 4-1, Mr. Goodman dissented. Dr. Satchell will prepare an Order.

An Order was adopted in #80-19, Mississippi River Grain, on motions to reconsider by a vote of 5-0. Mr. Goodman and Mrs. Anderson concurred. Dr. Satchell will prepare an Order.

Motion for extension of time to respond in #80--32, Planned Communities, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for modification was denied in #80-34, Rantoul, by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion for extension of time was granted in #79-28, Lockport, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for leave to withdraw appearance in #80-108, Woodlane, was granted by a vote of 5-0. Mrs. Anderson will prepare an Order.

Motions for extension of time to file briefs in R80-1 and R71-9, Radiation were granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to withdraw was granted in #80-109, Granite City Steel, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to hold records open in R77-15 et al, Sulfur Dioxide, was denied by a vote of 4-0, Mr. Werner abstained. A motion for leave to submit documentation by Celotex was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

An Order was adopted in #78-233, Granite City Steel, by a vote of 4-0. Dr. Satchell abstained.

An Order was adopted in R76-7, Mine Wastes, TDS, by a vote of 5-0.

Amended petitions in ##80-83, St. Clair Housing and 80-85, Allis-Chalmers, were ordered held for Agency recommendations.

A hearing was authorized in #80-108, Woodlane, amended petition #80-93, Wagner was ordered held to July 10, 1980. #80-82, Iber, was noted and hearing ordered to go on as scheduled.

Minutes as amended were approved by a vote of 5-0 for meetings held May 1, 15 and 29, 1980.

These cases were discussed and held for further discussion or possible decision on July 10: ##78-137, Salem; 78-240, Wood Dale; 79-11, Brogan v. Palos Hills; 79-75, Canfarelli v. Romeoville; 79-179, U.S. Steel; 79-251, Spartan Manufacturing; 80-53,-54, Mobil Oil; 80-74, Altona; 80-33, Alto Pass; 80-59, Wheeling; R80-2 and R80-7, Procedural Rules Amendments.

In new cases these actions were taken by a vote of 5-0: ##80-104, Cheatham v. French, hearing authorized; 80-111, EPA v. Caterpillar Tractor, 80-112, People v. Occhipinti, 80-113, EPA v. Archer-Daniels-Midland and 80-114, People v. Kraemer, hearings mandatory; 80-115, Department of Transportation, held for IEPA comment; 80-116, Borg-Warner, hearing authorized and stay granted to July 10, 1980, Order by Mr. Goodman.

R80-9, Blasting Noise Amendment, was authorized for hearing and publication by a vote of 5-0. Mrs. Anderson will prepare an Order.

A proposed amendment to Volatile Organic Emissions, filed by DeSoto et al, was construed as a motion under R80-5 and denied by a vote of 5-0. Mr. Goodman will prepare an Order.
