Minutes of Regular Board Meeting
August 21, 1980 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ## 78-271, CIPS; 79-106, DuPont; 79-116, Beckwith; 79-240, Cargill; 79-262, Maney & Heil; 80-42, Kraft; 80-51, Bensenville, Mr. Dumelle concurred; 80-85, Allis-Chalmers; 80-115, Department of Transportation (Order only).

Final Orders were adopted in R71-23 and R78-16, Sulfur Dioxide by a vote of 4-0. Mr. Werner abstained.

An Interim Order was adopted in R79-3. "CAP" by a vote of 5-0.

An Order was adopted in the matter of an interlocutory appeal in #78-177, Celotex, by a vote of 3-0. Dr. Satchell and Mr. Werner abstained. Mr. Goodman will prepare an Order.

Motion to reconsider was granted in #78-54, Amoco, by a vote of 4-1. Mrs. Anderson dissented. Mr. Goodman will prepare an Order.

Motion to correct the Order was granted in #80-33, Alto Pass, by a vote of 5-0. Mrs. Anderson will prepare an Order.

An Order was adopted in #80-60, Hillside, dismissing Count III of the complaint by a vote of 5-0. Mr. Goodman will prepare an Order.

Withdrawal of request for hearing was granted in #80-102, Marathon Oil, and an affidavit was requested. The vote was 5-0 and Mr. Goodman will prepare an Order.

Motions for extension of time to file recommendation in #80-124, Union Oil, was ordered taken with the case.

Motion to withdraw conditional waiver of hearing was granted in #80-144, Illinois Nitrogen by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion for continuance in # 78-50, North Shore, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for extension of time to file recommendation in #80-103, Homewood was ordered taken with the case.

Motion to strike a brief in #80-68, Clem Juris, was ordered taken with the case.
