The Board voted 4-1, Mr. Werner dissented, to renotice R76-14, -19, Forging Noise Regulations.

A Final Rule was adopted in R80-2, Procedural Rules, Rule 311, by a vote of 5-0.

An Order was adopted in # 79-145, Celotex, on a request for interlocutory appeal by a vote of 4-0. Mr. Werner abstained. Mr. Goodman will prepare an Order.

Motion for stay in #79-160, U.S. Steel, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

An Order was adopted on a motion for reconsideration in #79-161, Stepan Chemical, by a vote of 5-0. Dr. Satchell concurred. Mr. Goodman will prepare an Order.

The matter of #79-269, Montgomery v. Aurora, was dismissed by a vote of 5-0. Mrs. Anderson will prepare an Order.

An Order was adopted on a request for modification in #80-83, St. Clair Housing, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Request to withdraw in #80-104, Cheatham v. French, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss in #80-139, Elgin, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

#80-145, Herrin, was ordered held for an Agency recommendation. #80-146, Herrin, was dismissed. The votes were 5-0, Dr. Satchell will prepare the Orders.

Motion to keep the record open in R77-15 and R78-14, Sulfur Dioxide, was granted by a vote of 4-1, Mr. Werner dissented. Mr. Goodman will prepare an Order.

An objection was filed in #80-144, Illinois Nitrogen, and a hearing was authorized.

Proposed Amendments to Chapter 3: Water Pollution, filed by Galesburg Sanitary District were authorized for hearing and publication. Docket number R80-16 was assigned.
