Minutes of Regular Board Meeting
October 30, 1980 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0:
78-211, Guy Marlin, Mr. Dumelle and Mrs. Anderson concurred;
78-236, Kaney Transportation; 79-10, Zajac v. CTA; 79-70, Sand-
man; 79-254, Cantrell v. Gaines; 80-47, Knoxville.

A final Opinion and Order was adopted in R78-8, Public Water Supply,
Chlorination, by a vote of 5-0.

R80-6, Procedural Rules, Permits, was authorized for hearing and
first notice purposes by a vote of 5-0.

Motion for reconsideration in #78-121, Storey, was denied by a
vote of 5-0. Mrs. Anderson will prepare an Order.

Petitioner's motion to dismiss in #79-66, Nichols was granted
by a vote of 5-0. Mr. Dumelle will prepare an Order.

Complainant's motion to dismiss in #80-60, Hillside, was granted
by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time to file brief was granted in 80-63,
-64, Amax, by a vote of 4-0, Mr. Werner abstained. Motion for
summary Judgement was denied. Dr. Satchell will prepare an Order.

Motion for reconsideration was granted and motion for rehearing
was denied in #80-68, Clem Juris, by a vote of 5-0. Mrs. Anderson
will prepare an Order.

Hearing was authorized in #80-172, Medusa, pursuant to an objection
filed.

Motion to dismiss #80-175, Unity Ventures, was granted by a vote
of 3-2, Mr. Dumelle and Mr. Werner dissented. Mr. Goodman will prepare
an Order.

Motion for continuance was granted in #78-137, Salem, by a vote of
5-0. Mrs. Anderson will prepare an Order.

Motion for sanctions was granted in #79-215, Popp, by a vote of
5-0. Dr. Satchell will prepare an Order.

Motion to extend stay in #80-126, Olin, was granted by a vote
of 5-0. Mr. Dumelle will prepare an Order.

Motion to withdraw motion for expedited consideration was granted in #80-144, Illinois Nitrogen, by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion for hearing was granted in #80-163, Abingdon, by a vote of 5-0. Mr. Dumelle will prepare an Order.

Joint motion to consolidate #79-26 and #79-167, Continental Grain, was granted by a vote of 5-0. Mr. Goodman will prepare the Order.

An Order requesting additional information on the amended petition filed in #80-157, Tazewell, was adopted by a vote of 5-0. Mrs. Anderson will prepare an Order.

Amended petition in #80-161, Cairo and #80-179, Dietzgen were ordered held for Agency recommendation.

The Board adopted a Resolution concerning site-specific proposed rule changes by a vote of 5-0. Dr. Satchell will prepare the Resolution.

In new cases, # 80-184, Alliance et al. v. Akron Land et al., a hearing was authorized and the 90 day time period for decision was ordered to run from October 6, 1980, The vote was 5-0, Dr. Satchell will prepare an Order.

In other new cases these actions were taken by a vote of 5-0: ## 80-188, River Oaks, additional information requested, Order by Mr. Dumelle; 80-193, Caterpillar Tractor, additional information requested, Order by Dr. Satchell; 80-194, EPA v. Germantown and 80-195, EPA v. Core-Lube, hearing mandatory; 80-196, Illinois Power, hearing authorized; 80-197, EPA v. Jacksonville, hearing mandatory; 80-198 and 80-199, Illinois Department of Transportation, held to November 20 for discussion; 80-200, Central Illinois Public Service, held for an Agency recommendation.

The site-specific rule proposed rule amendments filed by Pfizer, Olin and Sauget were held pending receipt of amended proposals. The vote was 5-0 and Dr. Satchell will prepare Orders.

The scheduled meeting with the Institute of Natural Resources was held over to November 20.

Mr. Dumelle requested that regulations be moved along and that Mrs. Anderson and Kathleen Crowley were reviewing the adjudicatory case backlog.

All matters not disposed of as listed were ordered placed on an agenda for possible consideration on November 20.
