MINUTES OF REGULAR BOARD MEETING

December 4, 1980 Chicago, Illinois

All Board Members were present for the morning session save Mr. Goodman. Mr. Dumelle announced that the meeting would be recessed at 11:45 a.m. and reconvened at 2:00 p.m. when Mr. Goodman was expected.

Opinions and Orders were adopted in these cases by a vote of 4-0: #78-37, Oregon; 78-158, Streator; 78-208, Orangeville; 79-20, Wiggins Ferry; 80-17, Daum v. Roselle; 80-63, -64, Amax Coal (Order Only); 80-184, CIPS.

Motion to dismiss in #78-287, Bradley Heights, was granted by a vote of 4-0. Ms. Anderson will prepare an Order.

Motion to withdraw in #79-179, U.S. Steel, was granted by a vote of 4-0. Dr. Satchell will prepare an Order.

Motion for stay in 79-266, U.S. Steel was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

In #80-22, -193, Caterpillar, motion to consolidate was denied. A hearing was authorized in #80-193. The vote was 4-0. Mr. Dumelle will prepare an Order.

Motion to appear was granted in #80-140, Wilson and Shipler by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to join parties in #80-177, McLean County, was denied by a vote of 4-0. Dr. Satchell will prepare an Order.

Motion to dismiss in #80-191, Benton, was denied by a vote of 4-0. Mrs. Anderson will prepare an Order.

Pursuant to the objection filed in #80-208, Trivoli, a hearing was authorized.

An objection notice filed in R78-8, Public Water Supply Regulations, was construed as a motion for reconsideration and denied by a vote of 4-0. Mr. Dumelle will prepare an Order.

An Order was entered in #80-148, Printpack, which noted that the 90-day decision period would run from November 12 and that expedited consideration would be given upon receipt of the Agency's recommendation. The vote was 4-0. Mrs. Anderson will prepare an Order.

Mr. Dumelle noted that he abstained from voting on the October 17, 1980 minutes since he was not present at that meeting.

Minutes for meetings held October 30 and November 20, 1980 were approved by a vote of 4-0.

A final Order adopting amendments to the Procedural Rules was adopted in R80-7 by a vote of 3-0. Mr. Werner abstained.

These cases were discussed and held to December 18 for further discussion or possible decision: ##78-33, Lemkuhl; 78-137, Salem, 78-214, Pontiac; 80-170, Olin Corp.; R76-21, Effluent Standards.

In new cases these actions were taken by a vote of 4-0: ##80-201, Kenden, held to December 18; 80-217, EPA v. Beecher, hearing mandatory; 80-218, Mercy Hospital, held for an Agency recommendation; 80-219, DeSoto, held for an Agency recommendation.

A request for provisional relief filed by Central Illinois Public Service Co. was ordered held pending an official submission. It was determined that no action was necessary at this time.

The meeting was recessed until 2:00 p.m.

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##78-113, Chicago Heights; 80-129, Borg Warner; 80-158, Dept. of Energy; 80-169, American Can.

An Opinion and Order was adopted in #78-177, Celotex, by a vote of 4-1, Mr. Werner dissented.

R73-5, -13, Open Burning was dismissed by a vote of 5-0.

A Proposed Rule, First Notice was adopted in R77-12, WQS, Docket B, Sludge, by a vote of 5-0.

R80-9, -10, Blasting Noise Amendments were adopted as Emergency Rules by a vote of 5-0. The Proposed Rules, First Notice were adopted for the same proceeding by a vote of 4-0, Mr. Werner abstained.


Proposed Rules, Second Notice were adopted for R80-12, Procedural Rules Amendments by a vote of 5-0.

Motion to dismiss Count V of a complaint in #78-50, North Shore Sanitary Dist., was granted by a vote of 4-1. Mrs. Anderson dissented. Mr. Dumelle will prepare an Order.

##79-161, Stepan Chemical and 80-3, Caterpillar Tractor, were discussed and held to December 18.

All matters not considered or disposed of as listed were ordered held to December 18 for possible consideration.
