MINUTES OF REGULAR BOARD MEETING  
DECEMBER 6, 1989 CHICAGO, ILLINOIS

All Board Members were present save J. Theodore Meyer who was on vacation.

An Opinion and Order was adopted in #AC 88-93, City of Herrin, by a vote of 6-0. (JM)

An Opinion and Order was adopted in #89-69, Klausing Tree Service, by a vote of 6-0. (BF)

In R84-12, Trihalomethanes, an Adopted Rule, Final Order, Opinion and Order was adopted by a vote of 6-0. (JD)

In R88-21(A), Water Toxics Control, a Proposed Rule, Second Notice, Proposed Opinion and Order was adopted by a vote of 6-0. J. Dumelle concurred. (RF)

In R88-21(B), Water Toxics Control, a Proposed Rule, First Notice, Proposed Opinion and Order was adopted by a vote of 6-0. Messrs. J. Dumelle and B. Forcade concurred. (RF)

In R89-9, RCRA Update (January 1, 1989 through June 30, 1989), a Proposal for Public Comment, Proposed Opinion and Order was adopted by a vote of 6-0. (JA)

In R89-12, Pretreatment Update (January 1, 1989 through June 30, 1989), a Proposal for Public Comment, Proposed Opinion and Order was adopted by a vote of 6-0. (JA)

In #AC 89-237, Gary Jacobs, an Order construing Respondent's November 16, 1989 letter to the Board as a Petition for Review and directing the Clerk's office to send a copy of Respondent's letter to the Agency and a copy of the Environmental Protection Act and the Board's Procedural Rules to the Respondent, and ordering the Agency to file its response to Respondent's petition by December 15, 1989 in order that the Board may consider this matter further at its December 20, 1989 meeting, was adopted by a vote of 6-0. (JM)(Thereafter Chairman Marlin introduced Margaret Fliss as the new assistant to Board Member B. Forcade and announced that Debbie Schmitt has accepted a position with the USEPA and would be leaving the Board as of December 15, 1989, and that he has hired a new assistant)

Board Member B. Forcade presented a draft Proposed Rule, Second Notice, Opinion and Order in R88-19, Roadmaster Site-Specific. Amendments by J. Anderson were accepted and an amended Proposed Rule, Second Notice, Opinion and Order was adopted by a vote of 6-0. (BF)

Board Member M. Nardulli presented a draft Opinion and Order in #89-121, Metropolitan Waste Systems. Motion to amend by J. Dumelle and seconded by R. Flemal failed to carry by a vote of 3-3. Thereafter, the following actions were taken: the Opinion and Order were voted on separately. The Order affirming the City's denial of site location approval was adopted by a vote of 6-0; the Opinion regarding Criterion 1 and 2 were voted on separately. That part of the Opinion, excluding those portions addressing Criterion 1, was adopted by a vote of 6-0; that part of the Opinion addressing Criterion 1 failed to pass, the Board being deadlocked at a 3-3 vote. As a statutory majority of 4 votes could not be mustered for any written Opinion, there is no Opinion of the Board as to the Criterion 1 issue in this case. (MN)


