

MINUTES OF SPECIAL BOARD MEETING  
DECEMBER 4, 1990 CHICAGO, ILLINOIS

Pursuant to notice given Chairman Marlin called the meeting to order at 1:00 p.m. All Board Members were present save R. Flemal who was absent.

Petitioner's motion for extension of time was denied and Agency motion to reject request for extension of time was granted in #88-60, Sonoco Products, by a vote of 5-1. J. Anderson dissented. (JD)

Petitioner's motion to withdraw in #89-124, Wrico Packaging, was granted by a vote of 6-0. (BF)

An Order granting Petitioner's motions for summary judgment and for leave to file its reply brief instant and remanding the matter to the Agency with directions that it adhere to the procedures enunciated in Wells, was adopted in #90-22, Douglas Furniture, by a vote of 5-1. B. Forcade dissented. (MN)

Respondent's motion to dismiss was denied in #90-145, Gallatin National. Complainant's motion to recuse Hearing Officer will be addressed at the Board's December 20, 1990 Meeting. The vote was 6-0. (JD)

Metcalf & Eddy Services' motion for extension of time to respond to a November 8, 1990 Board Order in #90-184, Hopper Paper, was granted until January 4, 1991, by a vote of 6-0. (JD)

An Order accepting the matter for hearing, denying Petitioner's motion for stay, and advising Petitioner's that the Board will make every effort to issue its decision as expeditiously as possible, was adopted in #90-219, GSF Energy, by a vote of 6-0. (JA)

An Order construing Petitioner's request for oral argument as a request for hearing, and requesting testimony and comment on three enumerated issues during the hearing process was adopted in R90-24, Amendments to 35 Ill. Adm. Code 101.103(d) to Require Use of Recycled Paper for all Documents filed with the Board, by a vote of 6-0. (JTM)
