MINUTES OF REGULAR BOARD MEETING JUNE 7, 1990 CHICAGO, ILLINOIS

All Board Members were present.

By a vote of 7-0, and upon Chairman Marlin's motion, the Board decided to reschedule the regular meeting set for July 6 to July 3, 1990. The Clerk will post a notice.

An Opinion and Order was adopted in #AC 89-131 (Docket A & B), ESG Watts, by a vote of 6-1. J. Dumelle dissented. (MN)

An Opinion and Order was adopted in #89-206, Chicago Steel Container, by a vote of 6-1. J. Theodore Meyer dissented. (JD)

An Opinion and Order was adopted in #90-14, PQ Corporation, by a vote of 6-1. J. Theodore Meyer dissented. (JM)

An Opinion and Order was adopted in #90-15, Wisconsin Can Company, by a vote of 6-1. J. Theodore Meyer dissented. (BF)

In R84-44, City of Pana, a Proposed Rule, Second Notice, Proposed Opinion and Order was adopted by a vote of 7-0. (JM)

In R90-3, UST Update, USEPA, Regulations (July 1, 1989 through December 31, 1989), an Adopted Rule, Final Order, Opinion and Order was adopted by a vote of 7-0. (JA)

In R90-9, Used and Waste Tire Regulations, an Order determining that an Economic Impact Study is not required, was adopted by a vote of 7-0. (JM)

Board Member J. Anderson presented a draft Opinion and Order in R88-7, Landfill Regulations. Motion by B. Forcade to delete Section 811.101(B) and seconded by J. Dumelle failed by a 2-5 vote with J. Dumelle and B. Forcade for it and J. Anderson, R. Flemal, J. Marlin, J. Theodore Meyer and M. Nardulli against. A proposal by J. Theodore Meyer to change the two year exemption for new landfills to one year was accepted as a friendly amendment and the Opinion and Order was then adopted by a vote of 7-0. Messrs. J. Dumelle and B. Forcade concurred. (JA)

Default Orders were adopted in these Administrative Citations by a vote of 7-0: ##90-31, Lee Alexander; 90-35, Leroy Robinson.

Respondent's petition for reconsideration and clarification was denied in #AC 89-18 (Docket A & B), J & R Landfill, by a vote of 5-2. J. Dumelle and J. Anderson dissented. (JM)

Agency motion to withdraw complaint and dismiss action was granted in #AC 89-242, City of Rutland, by a vote of 7-0. (JM)

By a vote of 7-0, Respondent's motion to dismiss its petition for review was granted, and unless the penalty has already been paid, within 30 days of the entry of this Order, the Respondent was ordered to pay a penalty of \$500.00 in #AC 89-245, Bob White. (JM)

By a vote of 7-0, Respondent's motion to withdraw appeal was granted, and unless the penalty has already been paid, within 30 days of the entry of this Order, the Respondent was ordered to pay a penalty of \$500.00 in #AC 89-292 (Docket A), Land & Lakes Company. (JM)

Complainant's motion to dismiss in #AC 90-32, Mary Williams and Delores Bey, was granted by a vote of 7-0. (JM)

By a vote of 7-0, an Order requesting the parties to submit a status report no later than July 2, 1990, was adopted in #85-164, Western Illinois Power Cooperative. (JD)

An Order relinquishing jurisdiction and closing the docket in #86-3, City of Oglesby, was adopted by a vote of 6-1. J. Theodore Meyer dissented. (JA)

An Order requesting that the Petitioner file, no later than June 28, 1990, a motion to dismiss or other appropriate pleading addressing the mootness of the issues in its permit appeal in #86-124, Modine Manufacturing, was adopted by a vote of 7-0. (JD)

Respondent's petition to modify a September 8, 1988 Board Order in #86-193, City of Freeport, was denied by a vote of 7-0. (JM)

By a vote of 7-0, an Order requesting the parties to submit a status report no later than July 2, 1990, was adopted in #87-91, American Steel Container. (JD)

By a vote of 7-0, an Order directing the parties to submit a status report no later than October 1, 1990, was adopted in #87-150, Natural Gas Pipeline Company. (JD)

By a vote of 7-0, Complainants' motion to dismiss and join additional parties was granted and the case caption of the complaint was corrected to reflect the dismissal and joinder in #89-19, Daniel Lorden and Helen Lorden. (JM)

By a vote of 6-1, Petitioner's motion for leave to add additional counsel and to file supplemental exhibits was granted and because the additional exhibits submitted contained new information, the Board construed the filing as an amended petition and the 120 day decision timeclock was restarted as of June 4, 1990 in #89-183, City of Batavia. B. Forcade dissented. (JTM)

Board Member J. Anderson presented a draft Order to grant Complainant's motion to continue hearing in #90-73, Illinois Cement Company. Motion to deny Complainant's request by J. Theodore Meyer and seconded by M. Nardulli failed by a vote of 2-5 with J. Theodore Meyer and M. Nardulli for it and J. Anderson, J. Dumelle, R. Flemal, B. Forcade and J. Marlin against it. An amendment by J. Dumelle to strike a clause in the first paragraph of the draft Order and seconded by B. Forcade was accepted and the Order granting Complainant's motion to continue hearing for 120 days was adopted by a vote of 5-2. Messrs. J. Theodore Meyer and M. Nardulli dissented. (JA)

Petitioners James Ulmer, Eddie Ulmer, Duane Flowers and William Neers' motion to strike themselves as parties in #90-94, Horace File et al., was granted by a vote of 7-0. (MN)

By a vote of 7-0, the Board granted the Agency's motion to file Record Instanter in #90-95, ESG Watts. (JM)

An Order inviting all participants to submit, no later than June 18, 1990, their version of the proposed regulatory language was adopted in R87-31, SO₂ Averaging, by a vote of 7-0. (BF)

In R89-16(B), RACT Deficiencies, the Board on its own motion, adopted an Order informing the Agency that this rulemaking will be subject to dismissal on June 21, 1990 unless the Board is notified by the Agency that it intends to proceed with the amendments contained within Subdocket (B). The vote was 7-0. (JD)

This regulatory matter was discussed and held to June 21, 1990 for further discussion or possible decision: R88-21(B), Water Toxics, Adopted Rule, Final Order, Opinion and Order.

This adjusted standard was discussed and held to June 21, 1990 for further discussion or possible decision: #89-2, Elizabeth Street Foundry.
