Orders were adopted in these matters for codification: R81-7, Solid Waste and R81-9, Special Waste. The vote of 4-0.

A Final Order was adopted in R81-26, John Deere, by a vote of 4-0.

A Proposed Rule, First Notice and Proposed Opinion were adopted in R82-3, Alton Water Company by a vote of 4-0.

A Final Order and Final Opinion were adopted in R82-31, Forging Noise, Dockets A, B and C, by a vote of 4-0.

A Final Order was adopted in R83-6, Mine Waste (Docket B), by a vote of 4-0.
