MINUTES OF REGULAR BOARD MEETING February 9, 1984 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 7-0: ##83-103, Centralia; 83-120, ITT.

An Order was adopted in #83-106, American National Bank by a vote of 5-2. Mr. Nega and Mr. Meyer dissented.

A Proposed Rule, First Notice, Order, was adopted in R82-14, RACT III, by a vote of 7-0.

R83-28, Definition of Liquid Hazardous Waste, was ordered set for hearing.

A Resolution and Order was adopted in R84-2, New Source Performance Standards by a vote of 7-0.

Motion to reconsider in #80-175, Unity Venture, was denied by a vote of 7-0. Mrs. Anderson will prepare an Order.

In #81-18, Caterpillar, an objection to a Hearing Officer Order regarding interrogatories, was denied and the Hearing Officer ruling was affirmed. The vote was 6-1, Mr. Meyer dissented. Mr. Dumelle will prepare an Order.

Motion to dismiss in #81-170, OMC, was granted by a vote of 7-0. Mrs. Anderson will prepare an Order.

Motion for modification in #83-73, Searle, was granted by a vote of 6-0, Mr. Forcade abstained. Mr. Anderson will prepare an Order.

In #83-146, Sauget, the Board amended the original Order in response to a motion for reconsideration. The vote was 7-0, Mrs. Anderson will prepare an Order.

A motion for supplemental hearing in #83-147, Lombard, was granted with conditions by a vote of 7-0, Mr. Dumelle concurred. Mr. Forcade will prepare an Order.

In #83-150, Archer Daniels Midland, a motion for 90 day continuance of hearing was granted by a vote of 7-0. Mr. Dumelle will prepare an Order.

Motion to withdraw in #83-151, CIPS, was granted by a vote of 7-0. Mrs. Anderson will prepare an Order.

A second motion to dismiss in #83-163, Bittle et al., was granted in part and denied in part by a vote of 7-0. Mr. Dumelle and Mr. Anderson concurred. Mrs. Anderson will prepare an Order.

Motion for waiver of hearing in #83-175, National Can, was denied by a vote of 7-0. Mr. Forcade will prepare an Order.

Motion to withdraw in #83-176, Damson, was granted by a vote of 7-0. Mr. Dumelle will prepare an Order.

Motion to cancel hearing in #83-179, Georgia-Pacific was denied by a vote of 7-0. Mr. Dumelle will prepare an Order.

Motion to consolidate in ##84-3, -4, Galva, was granted by a vote of 7-0. Mr. Dumelle will prepare an Order.

An Order was adopted regarding a motion to reconsider in R80-16, Galesburg. The vote was 7-0, Mr. Dumelle will prepare an Order.

In amended petitions these actions were taken by a vote of 7-0: ##83-152, Mendota, held for an Agency recommendation; 83-166, Mobil, additional information requested, Order by Mr. Forcade; 83-233, Thrall Car, hearing authorized; 83-241, Moore Graphics, hearing authorized and additional information requested, Order by Mr. Forcade; 84-10, Orchard Hill, hearing authorized.

These cases were discussed and held to February 22, 1984 for further discussion or possible decision: ##79-210, Sours Grain; 81-132, Borden; 82-21, Galesburg; 82-55, Waste Management, remand; 83-157, Lamplighter, 83-167, Watts; 83-173, Industrial Salvage; 83-225, Beardstown.

These regulatory matters were discussed: R79-14, Air Quality Standards Amendments; R80-22(B), Winnetka; R81-25, Chlorinated Solvents; R82-1, Particulate Emission Limitations; R83-19, Lockport.

A Proposed Illinois Contingency Plan was docketed as R84-5 and authorized for hearing. Mrs. Anderson will prepare a draft for consideration at a later date.

In new cases these actions were taken by a vote of 7-0: ##84-7, Illinois Department of Transportation, Waukegan Port District, the Chairman was authorized to sign and prepare an Order; 84-12, Minutes for these regular and special Board meetings were approved as corrected by a vote of 7-0: December 6, 15, 23, 28 and 29, 1983; January 12, 1984.

Oral argument was then heard in the matters of ##83-228, -229, -230, St. Charles et al. v. Kane County Board et al., an emergency motion requesting the reversal of various hearing officer rulings related to discovery. The Board issued an Order affirming in part and reversing in part the hearing officer's Orders. The vote was 7-0, Mr. Dumelle will prepare an Order.

All other matters not disposed of as listed were ordered held to February 22, 1984 for possible consideration.
