MINUTES OF REGULAR BOARD MEETING
November 8, 1984 Chicago, Illinois

All Board Members were present.

An Opinion and Order was adopted in #83-4, East Moline, by a vote of 5-1. Mr. Dumelle dissented.

An Opinion and Order was adopted in #84-105, CIPS, by a vote of 6-0.

A Proposed Rule, Second Notice, Proposed Opinion and Order was adopted in R83-19, City of Lockport, by a vote of 5-1. Mr. Forcade dissented.

A Proposed Rule, Second Notice, Proposed Order was adopted in R83-28B, Definition of Liquid Hazardous Waste, by a vote of 6-0. Mr. Forcade concurred.

A Proposed Rule, Second Notice, Opinion and Order was adopted in R84-10, RCRA Procedural Rules, by a vote of 5-1. Mr. Meyer dissented; Dr. Marlin and Mr. Forcade concurred.

Application for non-disclosure and motion for Board rulings on certain motions in #79-145, Celotex, was denied by a vote of 6-0. Mr. Forcade will prepare the Orders.

Motion to revise Board Order in #80-151, Archer Daniels Midland, was granted by a vote of 6-0. Mr. Dumelle will prepare an Order.

The Board upon its own motion, modified the hearing schedule in #83-58, -59, Caterpillar, by a vote of 6-0. Mr. Forcade will prepare an Order.

Motion to dismiss was denied in #83-163, Larry Bittle, by a vote of 5-1; Mr. Meyer dissented. Mr. Forcade will prepare an Order.

An Order dismissing #83-175, National Can, and incorporating the record into that of #84-108, National Can, was adopted by a vote of 6-0. Mrs. Anderson will prepare the Order.

Motion for leave to file Recommendation Instantner was granted in #84-82, Reilly Tar, by a vote of 6-0. Mr. Forcade will prepare an Order.

Motion for reconsideration was granted in #84-95 through #84-104, Continental Grain, by a vote of 6-0. Mr. Dumelle will prepare an Order.

Motion to dismiss was denied and additional information was requested in #84-123, Village of Energy, by a vote of 6-0. Mrs. Anderson will prepare an Order.

An Order was adopted in #84-143, IBP, Inc., by a vote of 4-2; Mr. Dumelle and Mrs. Anderson dissented. Mr. Forcade will prepare the Order.

Motion to reinstate motion for expedited consideration was granted in R77-4, Airport Noise, by a vote of 6-0. Mr. Dumelle will prepare an Order.

The amended petition filed in #84-146, City of Tuscola, was held for an Agency recommendation.


