MINUTES OF REGULAR BOARD MEETING
September 3, 1981 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0:
77-157, Decatur Sanitary District; 80-4, Alba Manufacturing;
80-177, McLean County Services; 81-4, Knoxville; 81-19, Marion,
Mr. Goodman concurred; 81-30, Quincy; 81-57, Freeport; 81-60, Kaney
Transportation; 81-87, Sparton Manufacturing; 81-99, Hartford
(Order); 81-108, Fairfield.

An Opinion and Order was adopted in #80-225, GTE, by a vote of
3-2, Mr. Goodman and Mr. Werner dissented.

R78-7, Flouride, Proposed Rule, First Notice, was adopted by a vote
of 5-0.

Pursuant to a request for order by the Hearing Officer in #79-26,
-167, Continental Grain, the Board ordered a discovery schedule
be established and a hearing set as soon as possible. The vote
was 5-0, Mrs. Anderson will prepare an Order.

Motion for extension of time to respond to a motion for reconsi-
deration in #79-134, Commonwealth Edison, was granted by a vote
of 5-0. Mr. Goodman will prepare an Order.

Motion for rehearing in #81-12, Wauconda, was denied by a vote
of 5-0. Mrs. Anderson will prepare an Order.

In #81-104, Illinois Fruit, the record was ordered incorporated
into #80-181, Illinois Fruit, but not consolidated. The vote was
5-0, Mr. Anderson will prepare an Order.

Motion for extension of time to respond in #81-116, Victory Memorial
Hospital, was granted by a vote of 5-0. Mr. Dumelle will prepare
an Order.

Pursuant to an objection filed in #81-117, Olin, a hearing was
authorized.

An Order was adopted in R79-11, AQS, Rule 203(g), on a motion
for reconsideration. The vote was 5-0. Mr. Goodman will prepare
an Order.

Motion for change of hearing date was granted in #77-158, CIPS,
by a vote of 5-0. Mrs. Anderson will prepare an Order.

Motion to dismiss in #78-272, Commonwealth Edison, was granted
by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time in #81-118, Vickery Manor, was ordered taken with the case.

Motion to dismiss in #79-34, Granite City, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to extend time in #81-59, Carmi, was referred to the Hearing Officer.
