An Order granting the provisional variance, was adopted in #94-384, The Amoco Oil Company and The City of Wood River, by a vote of 6-0. (McF)


An Order granting the provisional variance, was adopted in #94-385, Shell Oil Company (Argo Terminal), by a vote of 4-0. (McF)
