**MINUTES OF REGULAR BOARD MEETING
NOVEMBER 3, 1994 CHICAGO, ILLINOIS**

After calling the meeting to order, Chairman Manning noted the absence of Board Member Joseph Yi who was attending a reunification meeting in Korea. Thereafter, the Clerk was asked for a roll call, and all Board Members in attendance answered present.


