An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$6,400.00, was adopted in #94-123, People of the State of Illinois v. Archer Daniels Midland Company, by a vote of 5-0. J. Theodore Meyer concurred. (RCF)

An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$1,000.00, was adopted in #94-389, People of the State of Illinois v. Village of Port Byron, by a vote of 5-0. J. Theodore Meyer concurred.

A provisional variance was granted in #95-45, Springfield Metro Sanitary District v. IEPA, by a vote of 5-0. (CAM)

An Order granting the Complainant's motion to dismiss was adopted in #AC 94-88, Sangamon County v. City of Springfield, by a vote of 5-0. (JCY)

An Order granting the Agency's motion to withdraw the complaint, was adopted in #AC 95-3, IEPA v. Environmental Reclamation Company, by a vote of 5-0. (CAM)



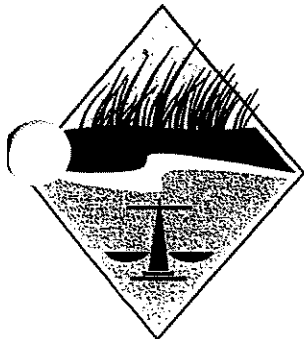
