**MINUTES OF REGULAR BOARD MEETING
FEBRUARY 16, 1995 CHICAGO, ILLINOIS**

After calling the meeting to order, Chairman Manning asked the Clerk for a roll call, and all Board Members answered present.

Minutes of the February 9, 1995 meeting were approved by a vote of 6-0. Board Member J. Theodore Meyer abstained.



A provisional variance was granted in #95-55, The Village of Sauget v. IEPA, by a vote of 7-0. (CAM)

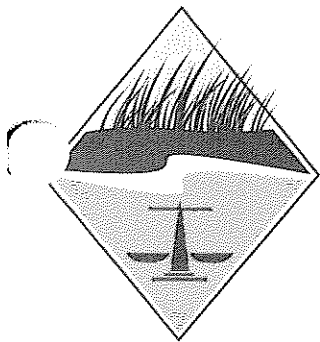

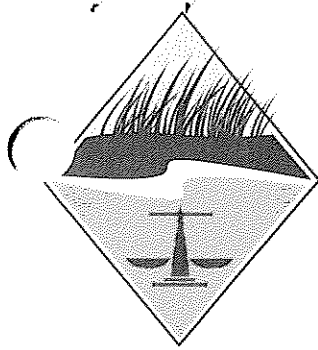
