**MINUTES OF REGULAR BOARD MEETING
MAY 18, 1995 CHICAGO, ILLINOIS**

After calling the meeting to order, Chairman Manning welcomed every one to the meeting and announced her reappointment as Chairman of the Board, and the reappointments of Marili McFawn and Joseph Yi, as Members. Thereafter, the Clerk was asked for a roll call and all Board members answered present except for Board Member Joseph Yi who was absent.



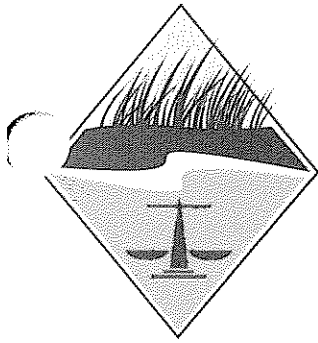
