MINUTES OF REGULAR BOARD MEETING
December 2, 1982 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0:
75-22 United Electric Coal; 75-80-141, U.S. Steel, Mrs. Anderson and Mr. Werner concurred; 82-15, Hamman; 82-85, Gilt Edge Farms; 82-109, Granite City Steel, Mr. Dumelle concurred.

An opinion and order were adopted in #80-111, Caterpillar Tractor, by a vote of 4-1. Mrs. Anderson concurred and Mr. Anderson dissented.

An Opinion and Order were adopted in #82-101, Browning-Ferris v. Lake County and EPA, by a vote of 4-1. Mr. Dumelle Dissented.

Mr. Werner was not present for the rest of the meeting.

A Proposed Rule, Second Notice and a Proposed Opinion were adopted in R81-17, Combined Sewer Overflow by a vote of 4-0.

A Proposed Rule, Second Notice and a Proposed Opinion were adopted in R81-20, Bubble Rules, by a vote of 4-0. Mr. Dumelle concurred.

The Board reaffirmed its Order of September 2, 1982 in #78-233, Granite City Steel. The vote was 3-1, Mr. Anderson concurred and Mr. Dumelle dissented. Mr. Goodman will prepare an Order.

Motion to withdraw by the People of the State of Illinois in 79-98, Lombard was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

In 79-145, Celotex, motion to disqualify was denied and the Board Order of October 14, 1982 reaffirmed by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to stay in #79-164, OMC, was granted to February 28, 1983 by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion for rehearing in #80-31, Burns v. Western Springs, was granted by a vote of 3-0, Mrs. Anderson abstained. Mr. Dumelle will prepare an Order.

Motion for modification in #80-71, Continental Grain, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

In #80-175, Unity Ventures, a motion for sanctions was granted which caused a motion to modify to be moot. The vote was 4-0, Mr. Goodman will prepare an Order.

Motion for stay in #81-98, Wasteland was denied except for the penalty by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for reconsideration in #82-23, Trojan, was held to Dec-

ember 16, 1982 for consideration.

Motion for reconsideration in #82-87, Union Oil, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to withdraw complaint in #82-97, Northbrook v. Atlantic Richfield, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to withdraw petition in #82-125, J.L. Clark, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

New case #82-135, Acme Barrel v. EPA, was authorized for hearing and additional information was requested. The vote was 4-0, Mr. Goodman will prepare an Order.

R82-32, New Source Performance Standards Amendments, were adopted by a vote of 4-0. Mr. Dumelle will prepare an Order.
