MINUTES OF REGULAR BOARD MEETING
January 16, 1975 Chicago, Illinois

All Board Members were present.

Opinions and orders were adopted by a vote of 4-0 in these cases: #73-264, Carlyle; 74-377, Highland Supply; 74-393, Mobil Oil; 74-423, Illinois Power; 74-399, Havens; 74-85 and 74-194, Lakeland Park Water Co. (interim order).

R72-18, Grain Handling was discussed and the Board voted 4-0 to publish a proposed final draft in the next newsletter for public comment.

R73-15, Fluorides was discussed and the Board voted 4-0 to publish a proposed final draft in the next newsletter for public comment.

Motion to modify in #73-551, Republic Steel was denied by a vote of 3-1, Mr. Dumelle will prepare an order. Mr. Henss dissented.

Oral argument request in #74-33, Hall was denied by a vote of 4-0, Mr. Dumelle will prepare an order.

A motion in #74-140, Western Piece Dyers was referred to the Hearing Officer for ruling by a vote of 4-0, Mr. Dumelle will prepare an order.

Motion for extension of time in R71-24, Beverage Containers was granted to February 1, 1975 and motion for oral argument was denied by a vote of 3-0, Mr. Zeitlin abstained. Mr. Dumelle will prepare an order.

#74-334, American National Bank was dismissed by a vote of 4-0 for failure to submit additional information as requested. Mr. Dumelle will prepare an order.

Amended petitions were filed in these cases and the Board ordered them held for Agency recommendations: #74-468, Amoco; 74-444, Woodruff and Edwards.

These cases were discussed and held to January 23, 1975 for further discussion or possible decision: #74-245, CBE v. Woodruff; 74-177 and 74-178, Citywide Services; 73-279, Sizelove; R73-4, WQS Amendments (opinion only); 74-201, 74-270, 74-317, Stepan Chemical.

A proposed final draft in R73-8, 10, 17, Sulfuric Acid Mist was discussed by Mr. Hohman and authorized by a vote of 4-0 to publish in the next Board newsletter.

In new cases these actions were taken by a vote of 5-0: #75-14, City of Plano, held to 1/23; 75-15, City of White Hall, dismissed as moot, order by Mr. Dumelle; 75-16, J.L. Clark, hearing authorized and additional information requested, order by Mr. Dumelle; 75-17, Nabisco, ordered held for an Agency recommendation.

The Board decided to cancel the regular Board meeting scheduled for January 30, 1975.

All matters not disposed of as listed were ordered placed on the agenda for January 23, 1975.
