MINUTES OF REGULAR BOARD MEETING
June 6, 1975 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##74-277, International Harvester; 74-351, Wheaton Sanitary District; 74-446, Freeding; 74-476, Nelson; 75-115, Illinois Youth Center; 74-386, Marengo.

An Opinion and Order was adopted by a vote of 4-1 in #75-350, Archer-Daniels-Midland, Mr. Dumelle dissented.

A hearing was authorized in #75-75, American National Bank by a vote of 5-0.

Motions to continue hearings were granted in ##73-216,-285,-286,-457 and 75-62, City of Chicago. Mr. Dumelle will prepare the Orders.

The Board denied a motion in #73-330, Ozite by a vote of 5-0. Mr. Henss will prepare an Order.

Motion in #74-16, Commonwealth Edison was denied by a vote of 5-0. Mr. Goodman will prepare the Order.

Motion to continue was granted in #74-480, Forty-eight Insulations by a vote of 5-0. Dr. Odell will prepare an Order.

Motion to admit attorneys in #75-11, Republic Steel was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

An Order was entered in ##75-33,-65, Round Lake Sanitary District allowing a briefing schedule by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to consolidate in ##75-95,-118, Star Utility was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss in #75-118, Star Utility was denied by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss certain respondents in #75-120, Larsen was granted by a vote of 5-0, Mr. Zeitlin will prepare an Order.

An Order was entered in #75-134, Amco on an objection and motion for hearing by a vote of 5-0, Mr. Zeitlin will prepare an Order.

Petition to intervene by S.O.R.E. was granted in #75-175, CPC by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for time to respond to an Order of the Board in #75-192, Western Illinois Power was granted by a vote of 5-0. Dr. Odell will prepare an Order.

Motion to admit attorneys in R74-15,-16, WQS Amendments was granted by a vote of 5-0. Mr. Zeitlin will prepare an Order.

An Opinion and Order was adopted by a vote of 5-0 in #74-281, Mascoutah.
