MINUTES OF REGULAR BOARD MEETING
February 26, 1976 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##73-403,-418, Wells Mfg., 75-329, Apeco; 75-462, Lincoln Center; 75-176, CPC.

An Opinion and Order was adopted in #75-338, Metropolitan Sanitary District by a vote of 4-0, Mr. Young abstained.

An Opinion and Order was adopted in #75-446, Wirco Castings by a vote of 4-1, Mr. Dumelle dissented and will file a dissenting Opinion.

Motion filed in ##73-403, -418, Wells Mfg. on February 24, 1976 was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time to file reports in ##74-223,-229, NSSD was granted by a vote of 5-0. Mr. Zeitlin will prepare an Order.

An Order was entered in #75-41, Mt. Carmel pursuant to a letter of request filed by petitioner by a vote of 5-0. Mr. Goodman will prepare the Order.

Motion for leave to file an amended complaint in #75-218, Epperson was granted by a vote of 5-0. Mr. Zeitlin will prepare an Order.

A letter dated February 25, 1976 was construed as a motion to return bond in #73-445, Celotex and granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to withdraw petition in #75-378, Caterpillar Tractor was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #75-494, Piolet Brothers was denied by a vote of 5-0. Mr. Young will prepare an Order.

Motion to amend complaint in #76-7, Chicago Bulk was granted by a vote of 5-0. Mr. Zeitlin will prepare an Order.

Motion to dismiss in #75-288, Carling Brewing was granted by a vote of 5-0. Mr. Zeitlin will prepare an Order.

Additional information having been filed #76-4, Intercontinental Alloys was ordered held for an Agency recommendation.

R75-13, Petition filed by Olin Corporation regarding explosive wastes was dismissed by a vote of 5-0. Mr. Dumelle will prepare an Order.

Mr. Zeitlin announced that a letter had been received from Mr. Booras Director of the Insitute for Environmental Quality asking to withdraw the recently filed economic impact report (as announced in the Board Minutes of February 11, 1976) in the matter of R74-15,-16, Cyanides for further study.

In new cases these actions were taken by a vote of 5-0: #76-7, People v. Bulk Equipment, hearing authorized; 76-45, Olin Corporation, ordered held for an Agency recommendation; 76-46, Richard D. Miller, Inc., additional information requested, Order by Mr. Dumelle; 76-47 and 76-48, Illinois Department of Transportation permit applications, referred to Agency for comment; 76-49, Village of Orangeville, dismissed, Order by Mr. Zeitlin; 76-50, E.W. Kneip, Inc., held for an Agency recommendation.

A proposal for WQS Amendments filed by the Illinois EPA on February 20, 1976 was ordered given the #R76-4 and authorized for hearing and for publication in the Environmental Register.

A proposal for AQS Amendments filed by Deere and Co. on February 20, 1976 with over 200 signatures was ordered given the #R76-5 and authorized for hearing and for publication in the Environmental Register.

All matters not disposed of as listed were ordered placed on an agenda for March 11, 1976 for possible disposition.
