MINUTES OF REGULAR BOARD MEETING
March 25, 1976 Chicago, Illinois

All Board Members were present.

Motion for reconsideration in #75-285, Bingham was denied by a vote of 5-0, Mr. Young will prepare an Order.

Motion for reconsideration in #75-329, Apeco was denied by a vote of 5-0, Mr. Zeitlin will prepare an Order.

An Order was entered in #75-368, Commonwealth Edison concerning admissions by a vote of 5-0, Mr. Goodman will prepare an Order.

An Order was entered in #75-478, Sexton with regard to a motion to dismiss and summary judgment by a vote of 5-0, Mr. Zeitlin will prepare the Order.

Motion for injunction in #76-6, Tarkowski was denied by a vote of 5-0, Mr. Goodman will prepare an Order.

#76-17, Ottawa Silica, a motion to dismiss was dismissed as moot by a vote of 5-0, Mr. Goodman will prepare an Order.

Motion for leave to appear in #76-30, DuPont was granted by a vote of 5-0, Dr. Satchell will prepare an Order.

In R76-3, a motion to leave to appear was granted by a vote of 5-0. Pursuant to Illinois EPA response the proceeding was then dismissed by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion for leave to file closing argument in #75-426, Land America was granted by a vote of 5-0. Mr. Zeitlin will prepare an Order.

R76-7, Amendments to Chapter 4: Mine Related Pollution filed by Illinois Coal Operators Association was authorized for hearing and for publication in the Environmental Register by a vote of 5-0. Mr. Dumelle will prepare an Order.
