MINUTES OF REGULAR BOARD MEETING
February 17, 1977 Chicago, Illinois

All Board Members were present save Mr. Young.

Opinions and Orders were adopted by a vote of 4-0 in these cases: #75-496,-508, Alton Box Board; 76-69, Presnell; 76-186, Ashland, Mr. Zeitlin concurred and will file a concurring Opinion; 76-218, Flintkote; 76-297, E. St. Louis; 76-298, Alton Water Co.

Motion to dismiss by petitioner in #75-478, Sexton, was granted by a vote of 4-0. Mr. Zeitlin will prepare an Order.

Motion to amend in ##76-56 and 76-220, Fox Valley was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to extend time to file Agency recommendation was granted by a vote 4-0 in #76-222, International Harvester. No written order.

In #76-269, Holiday Utilities, a letter of request was construed as a motion for hearing by petitioner and a hearing was authorized by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to amend in #76-304, Targosz was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to intervene and amend in #76-310, Interlake was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to amend in #76-316, DuPage was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to amend in #76-323, Hinsdale was granted by a vote of 4-0. Mr. Zeitlin will prepare an Order.

An objection having been filed, a hearing was authorized in #77-11, F.I.D.C. by a vote of 4-0.

Motion to withdraw by petitioner in #77-34, CIPS was granted by a vote of 4-0. Mr. Zeitlin will prepare the Order.

Motion to dismiss in #77-37, Daubs was denied by a vote of 4-0. Mr. Zeitlin will prepare an Order.

Record in #76-155, Chicago & N.W. R.R. was reopened on the Board's own motion to received evidence by a vote of 4-0. Mr. Young will be assigned to prepare the Order.

A proposal for regulatory change filed by Sherwin Williams et al on February 15, 1977 was authorized for hearing and publication. #R77-3 was assigned to the proposal.

A proposal on Airport Noise Standards filed by the Illinois Attorney General, William Scott was discussed and held to March 3 for action.

A proposed regulatory amendment in SO₂ filed by the Illinois Manufacturers' Association was dismissed as duplicitous by a vote of 4-0. Mr. Goodman will prepare an Order.

All matters not disposed of as listed were ordered held to March 3, 1977 and placed on the agenda for possible action and consideration.
