April 14, 1977 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases:
##75-283, Enders v. Glendale Heights, Mr. Dumelle concurred and will file a concurring Opinion; 76-173, Jersey Sanitation; 77-47, Atlanta.

An Opinion and Order was adopted in #76-161, Stepan Chemical by a vote of 4-1, Mr. Dumelle dissented.

R74-10, Motor Vehicle Noise Regulations was discussed and set for decision on April 28, 1977.

Browning - Ferris, hearing authorized; 77-102, City of Quincy, held for an Agency recommendation; 77-103, Park Forest South Utilities, hearing authorized; 77-104, Village of Stewardson, held for an Agency recommendation.

Parties were present in #77-88, Metropolitan Sanitary District, motion for Interim Relief. The Board heard oral argument and the proceedings were transcribed. The Board voted 4-0 to deny the motion. Mr. Goodman will prepare the Order. Mr. Young took no part in the discussion or decision of the motion.

A proposal to amend the WQS, Rule 404(f) filed by Chrysler was authorized for hearing and publication and assigned R#77-8 by a vote of 5-0.

A proposal to amend the AQS, Rule 204.1 was authorized for hearing and publication and assigned R#77-9 by a vote of 5-0.

The Board then went into a closed administrative session with Ms. Wiley.

All matters not disposed of as listed were ordered placed on the agenda for April 28, 1977 for consideration.
