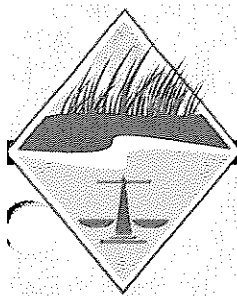
There being no further business, Chairman Manning adjourned the meeting at 11:05 a.m..
