All Board Members were present.

An Opinion and Order was adopted in #87-16, City of Lockport, by a vote of 4-2. Messrs. Dumelle and Forcade dissented. **(RF)** 

An Order dismissing the petition in R86-25, Village of Tilton, was adopted by a vote of 6-0. (JM)

An Adopted Rule, Final Order, Opinion and Order was adopted in R86-34, Municipal Incineration Definition, by a vote of 6-0. (RF)

An Order directing the Agency to file by June 19 its response to a motion to vacate Board Order in AC-87-27, Fitz-Mar Landfill, was adopted by a vote of 6-0. (JA)

Motion for reconsideration was denied in #83-163, Larry Bittle, by a vote of 6-0. J. Anderson concurred. (RF)

Motion for modification of Board Order was granted until July 1 in #84-124, Overnite Transportation, by a vote of 6-0. (BF)

An Order directing the Respondent to file by June 19 its response to the Agency's answer to motion to dismiss in #86-160, Fitz-Mar Landfill, was adopted by a vote of 6-0. (JA)

Motion for leave to file instanter and response to Agency's first amended Recommendation was granted and construed as a second amended petition thus restarting the 120 day decision time clock in #86-225, City of Geneva, by a vote of 6-0. (JA)
