ORDER OF THE BOARD (by M. Gibson):

On June 9, 2025, the Illinois Environmental Protection Agency (Agency) filed a recommendation that the Board certify livestock waste management facilities of Steffes Farm as pollution control facilities for preferential tax treatment under the Property Tax Code. *See* 35 ILCS 200/11-5 *et seq.* (2024); 35 Ill. Adm. Code 125. Steffes Farm's livestock waste management facilities are located at 5127 East Bethel Road in Elizabeth, Jo Daviess County. In this order, the Board describes the legal framework for tax certifications, discusses the Agency's recommendation, and certifies that Steffes Farm's identified manure management structures are pollution control facilities.

LEGAL FRAMEWORK

Under the Property Tax Code, "[i]t is the policy of this State that pollution control facilities should be valued, at 33 1/3% of the fair cash value of their economic productivity to their owners." 35 ILCS 200/11-5 (2024); see also 35 Ill. Adm. Code 125.200(a)(2). "For tax purposes, pollution control facilities shall be certified as such by the Pollution Control Board and shall be assessed by the Department [of Revenue]." 35 ILCS 200/11-20 (2024); see also 35 Ill. Adm. Code 125.200(a). Under the statute, the Board determines if the facilities are pollution control facilities; however, the Board is not authorized to assess a value of those facilities.

Under Section 125.202 of the Board's procedural rules, a person may submit an application for tax certification to the Agency. *See* 35 Ill. Adm. Code 125.202. If the Agency receives a tax certification application, the Agency must file with the Board a recommendation on the application, unless the applicant withdraws the application. *See* 35 Ill. Adm. Code 125.204(a). Among other things, the Agency's filing must recommend that the Board issue or deny tax certification. *See* 35 Ill. Adm. Code 125.204(a)(4). If the Board finds "that the claimed facility or relevant portion thereof is a pollution control facility . . ., the Pollution Control Board . . . shall enter a finding and issue a certificate to that effect." 35 ILCS 200/11-25 (2024); *see also* 35 Ill. Adm. Code 125.216(a).

AGENCY RECOMMENDATION

The Agency states that it received a tax certification application from Steffes Farm on July 20, 2023. Rec. at 1. On July 9, 2025, the Agency filed a recommendation with the Board, attaching Steffes Farm's application (Rec. Exh. A). The Agency's recommendation identifies the facilities at issue:

- One (1) concrete manure scrape alley measuring approximately 259 ft. (length) x 10 ft. (width) and associated steel automatic alley scraper.
- One (1) concrete manure scrape alley measuring approximately 259 ft. (length) x 12 ft. (width) and associated steel automatic alley scraper.
- One (1) concrete manure scrape alley measuring approximately 263 ft. (length) x 12 ft. (width) and associated steel automatic alley scraper.
- One (1) concrete manure scrape alley measuring approximately 263 ft. (length) x 10 ft. (width) and associated steel automatic alley scraper.
- Two (2) alley scraper drive systems and all associated motors and electrical components operating the above-mentioned automatic alley scrapers.
- One (1) concrete manure scrape alley measuring designated as East transfer alley measuring 120 ft.(length) x 17 ft. (width) used to back drag manure into auger area.
- One (1) reinforced concrete manure transfer auger pit measuring approximately 120 ft. (length) x 16 in. (width) x 16 in. (height), the associated 12 in. (diameter) steel manure transfer auger, the motor and all associated electrical components, and the associated flooring covering the pit.
- One (1) milk house water pump used for wash water for the robotic milkers. This wash water contains manure and is transferred to the manure pit. *Id*.

The Agency further describes the facilities: "These livestock waste management facilities are used to collect, transport and/or store livestock waste prior to cropland application." *Id.* at 2.

The Agency recommends that the Board certify that the livestock waste management facilities are pollution control facilities as defined in Section 11-10 of the Property Tax Code (35 ILCS 200/11-10 (2024)) with the primary purpose of eliminating, preventing, or reducing water pollution. Rec. at 1; *see also* Rec., Agency Memorandum.

TAX CERTIFICATE

Based upon the Agency's recommendation, Steffes Farm's application, and the Board's technical review, the Board finds and certifies that Steffes Farm's livestock waste management

facilities identified in this order are pollution control facilities under the Property Tax Code (35 ILCS 200/11-10 (2024)). The Board makes no finding regarding the assessed value of those facilities. Under Section 11-25 of the Property Tax Code, the effective date of this certificate is "the date of application for the certificate or the date of the construction of the facility, which ever is later." 35 ILCS 200/11-25 (2024); see also 35 Ill. Adm. Code 125.216(a). Section 125.216(d) of the Board's procedural rules states that the Clerk "will provide the applicant and the Agency with a copy of the Board's order setting forth the Board's findings and certificate, if any." 35 Ill. Adm. Code 125.216(d) (quoting in italics 35 ILCS 200/11-30 (2024)). The Clerk therefore will provide Steffes Farm and the Agency with a copy of this order.

IT IS SO ORDERED.

Section 11-60 of the Property Tax Code provides that any applicant or holder aggrieved by the issuance, refusal to issue, denial, revocation, modification or restriction of a pollution control certificate or a low sulfur dioxide emission coal fueled device certificate may appeal the Board's finding and order to the Circuit Court under the Administrative Review Law (735 ILCS 5/3-101 *et seq.* (2024)). See 35 ILCS 200/11-60 (2024). Within 35 days after receiving this final Board order, a party to this Board proceeding may file a motion asking the Board to reconsider or modify the order. 35 Ill. Adm. Code 101.520. Filing a motion to reconsider this final Board order is not a prerequisite to appealing the order. 35 Ill. Adm. Code 101.902.
