- Summary and Purpose of Rulemaking: This sub-docket explored four issues raised during the rulemaking process for 35 Ill. Adm. Code 845. Those four issues are: 1) historic, unconsolidated coal ash fill in the State; (2) the use of temporary storage piles of coal ash, including time and volume limits; (3) fugitive dust monitoring plans for areas surrounding CCR surface impoundments; and (4) the use of environmental justice screening tools.
