

**HEARING OFFICER ORDER**

On March 26, 2026, all parties participated in a telephonic status conference with the hearing officer. It is noted that respondent Kintzle Construction has settled and a stipulation and proposal for settlement (stipulation) has been accepted by the Board. Respondent Paragon Pork and the complainant are close to settlement and anticipates filing a stipulation in the next few weeks. By agreement, the answer due date for respondent Paragon Pork is June 18, 2026, if needed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 4, 2026, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, and provide a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.


