OPEN WAIVER OF DECISION DEADLINE

Petitioner, Waste Management of Illinois, Inc., by and through its attorneys, Nijman Franzetti LLP, pursuant to 35 Ill. Admin. Code §101.308(c)(1), hereby agrees to an open waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in the above-referenced proceeding. In support, the Petitioner states as follows:

1. In a final determination on October 27, 2025, the Illinois Environmental Protection Agency (“Illinois EPA” or “Agency”) issued to Petitioner a Class 1* permit modification concerning Solid Waste Management Units (“SWMUs”) at Areas 1 and 2 (“Areas 1 and 2”) and Hazardous Waste Management Units (HWMUs) at Areas 3 and 4 (“Areas 3 and 4”) of the CID Recycling & Disposal facility (“CID RDF”) (RCRA Permit Log Nos. B-27R2-M-8 and B-27R2-M-10).
2. On March 9, 2026, Petitioner filed an Appeal and Request for Partial Stay of certain Permit conditions relating to Areas 3 and 4.
3. On March 19, 2026, the Board accepted Petitioner’s Petition for hearing.
4. On March 2, 2026, the Board granted Petitioner’s Request for Partial Stay.

5. To allow for time to conduct discovery, Petitioner hereby voluntarily agrees to an open waiver of the statutory 120-day decision deadline.

WHEREFORE, Petitioner, Waste Management of Illinois, Inc., requests that the Board accept this open waiver of the statutory 120-day decision deadline on Petitioner's Appeal of Permit Conditions at Areas 3 and 4 of CID RDF.
