This order follows the Board's interim order of November 11, 2001, which found that this respondent had violated Sections 21(p)(1) and (p)(3) of the Environmental Protection Act (415 ILCS 5/21(p)(1), (p)(3) (2000)) and assessed a penalty of \$3,000 at respondent's Franklin County facility.	7-0

<b>AC 02-25</b>	<u>IEPA v. Robert Wiersema</u> – The Board dismissed respondent's petition for review for lack of jurisdiction. 
