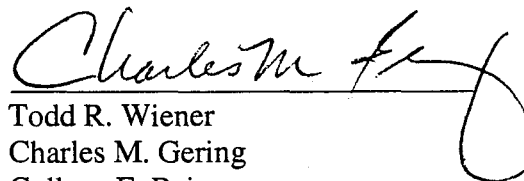

WAIVER OF DECISION DEADLINE

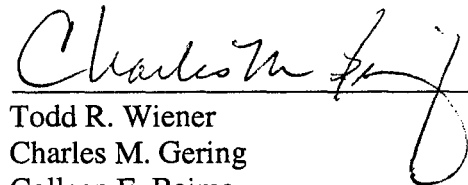
Petitioner NORTH SAFETY PRODUCTS, INC., by and through its counsel,

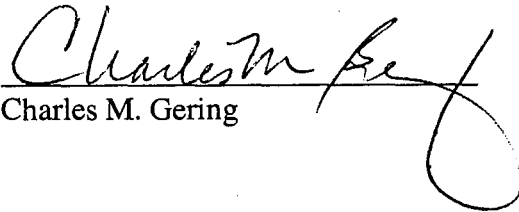
