**NOTICE OF PETITION BY HAYDEN WRECKING CORPORATION FOR AN ADJUSTED STANDARD BEFORE THE ILLINOIS POLLUTION CONTROL BOARD**

Notice is given of the filing of a Petition for an Adjusted Standard before the Illinois Pollution Control Board by Hayden Wrecking Corporation, 4201 St. Clair Avenue, Washington Park, Illinois 62203. Said Petition was filed on April 29, 2004, Board Docket No. AS 04-003, seeking an adjustment from the Class I groundwater standards for four inorganic chemicals codified at 35 Ill. Adm. Code § 620.410(a). The proposed adjusted standard is for the chemical constituents Arsenic, Iron, Lead and Manganese as indicated in the table (Figure 1).

Constituent	Units	Standard	Proposed Standard
Arsenic	mg/L	0.05	0.082
Iron	mg/L	5.0	735
Lead	mg/L	0.0075	0.220
Manganese	mg/L	0.15	24.2

Petitioner's activity at the site is limited to a lease dated October 14, 1999 of the site for parking on compacted, graded limestone to Gateway Motorsports Corporation. Gateway Motorsports Corporation's parking facilities are located near the intersection of Illinois Route 203 and Interstate 55/70 in St. Clair County, Illinois. Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice. The hearing request should clearly indicate the docket number for the adjusted standard proceeding, as found in this notice, and must be mailed to the Clerk of the Board, Illinois Pollution Control Board, 100 W. Randolph Street, Suite 11-500, Chicago, Illinois 60601.
