#### **JURISDICTION**

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2002).

#### **FACTS**

- 1. That Robert Daniel Spears ("Respondent") is the present owner and operator of a facility located at 4791 U.S. Highway 67, Beardstown, Cass County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Hagener Township/ Spears.
- 2. That said facility is an open dump operating without an Illinois Environmental Protection Agency Operating Permit and is designated with Site Code No. 0178055003.
  - 3. That Respondent has owned and operated said facility at all times pertinent hereto.
- 4. That on December 15, 2004, Charlie King of the Illinois Environmental Protection Agency's Springfield Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

#### **VIOLATIONS**

Based upon direct observations made by Charlie King during the course of his December 15, 2004 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondent caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2002).
- (2) That Respondent caused or allowed the open dumping of waste in a manner resulting in open burning, a violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3) (2002).

#### **CIVIL PENALTY**

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2002), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Three Thousand Dollars (\$3,000.00)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>March 1, 2005</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2002), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each

violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2002), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

# PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2002). If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.



#### NARRATIVE RE-INSPECTION REPORT DOCUMENT

The purpose of this memorandum is to serve as the Narrative Re-Inspection Report Document of a re-inspection conducted at the subject site on December 15, 2004 from approximately 1:50 p.m. until 2:15 p.m., by this author. I was accompanied on the reinspection by David C. Jansen, Manager, IEPA/DLPC/FOS - Springfield Region, and, Kristin Laughridge, Assistant Attorney General (AAG), Illinois Attorney General's Office (IAGO). The re-inspection was conducted to follow-up the September 2, 2004 initial site inspection, which was in response to a complaint received at the DLPC/FOS Springfield Regional Office. The original site inspection was reported in the Narrative Inspection Report Document Memorandum to the Land Division File, from this author, dated September 21, 2004. That initial inspection resulted in the issuance of two identical Administrative Citation Warning Notices (ACWNs). One was mailed to Robert and Dusty Spears, and the other to Bobbye Spears. No response to the ACWN was received from Robert or Dusty Spears. However, it turns out that although Bobbye Spears' name was on the Warranty Deed for the property, she was divorced from Robert Spears. On her behalf, her attorney, Thomas L. Veith of Bellatti, Fay, Bellatti & Beard Law Offices in Jacksonville, Illinois, sent a letter to the Illinois EPA dated November 30, 2004. That letter points out that Mr. and Mrs. Spears had separated in the fall of 2002 and during that time, Mr. Spears and his sons had possession of the property. Further, in the Judgment of Dissolution of Marriage, which Mr. Veith attached to his letter, as part of the settlement, Mr. Spears caused the conditions that resulted in the ACWN, and the Spears' agreed that Mr. Spears should be responsible for the cleanup of the marital residence, and any costs of cleanup or fines levied by the Illinois EPA. It further states that "... Husband shall remove all vehicles currently stored upon the above premises and other waste within 30 days from the date hereof...and hold Wife harmless from any liability...in violation of the Illinois Environmental Protection Act, including clean up costs and fines that may be imposed by such violations (ref. State of Illinois, In the Circuit Court for the Eighth Judicial Circuit, County of Cass, Marital Settlement Agreement No. 02-D-73, Article II, Marital Residence)." The Judgment for Dissolution

of Marriage was signed by both Robert Daniel Spears and Bobbye Jeanette Spears, their attorneys and the judge assigned to the case. It was dated October 4, 2004, more than 30 days prior to the re-inspection.

The re-inspection resulted in the finding that evidence of open dumping and open burning were still present at the property. Dusty Spears had removed all vehicles that were inoperable that were his responsibilities.

The site is located approximately five miles south of the City of Beardstown at 4791 U. S. Highway 67 South. This property is on the northwest corner of the intersection of U. S. Highway 67 South and (LaGrange) Lock and Dam Road, except for a fenced CIPS electrical sub-station on the southeast corner. Across U. S. Highway 67 to the east, Lock and Dam Road is named Hagener Road. The mailbox on-site reads Bob (&) Bobbye Spears, although Bobbye Spears lives at this address, and Bob Spears no longer lives there. As mentioned, the Spears are divorced. Her son, Dusty Spears, reportedly no longer lives at the property, but does repair vehicles there from time-to-time.

Legally and specifically, the site is located on two parcels. Partial descriptions are provided as follows: The first parcel is part of the East Half of the Northeast Quarter of Section Seven, Township 17 N, Range 12 West of the Third Principal Meridian. An additional detailed description is provided on the Warranty Deed, No. 92074, Book 156, page 427, filed May 10, 1988. The second parcel is part of the West Half, Northeast Quarter, Section Seven, Township 17N, Range 12 West of the Third Principal Meridian. An additional detailed description is provided on the Warranty Deed, No. 92075, book 156, page 428, filed May 10, 1988. The grantors conveyed and quitclaimed the properties to Robert D. Spears and Bobbye J. Spears as joint tenants, not as tenants in common. However, since their divorce, Bobbye J. Spears reportedly bought out Robert D. Spears interest in the house, and she is now the sole owner of the property. A copy of an updated Deed has not yet been provided to, or obtained by, the Illinois EPA. However, it may be a few weeks or months until an updated deed is available.

Upon arrival at the site on the day of the inspection, the weather was partly cloudy, with an air temperature of approximately 45 degrees. Winds were westerly at approximately 5 mph. Surface soil conditions were mostly dry, but damp in places.

During the course of the physical re-inspection, 14 photographs were taken with a digital camera. They show the conditions at the site on the day of the re-inspection. From the re-inspection, the previous inspection report and the inspection photographs, a partially computer generated sketch of the site was developed by this author. The digital camera provides a three-digit number to each photograph, i.e., 001, 002, etc. This is how the photographs are referred to in this narrative and in the Digital Photographs. However, to save space, real numbers were used on the Site Sketch, i.e., 1, 2, etc. Copies of the Digital Photographs and the Site Sketch accompany this report.

Upon arrival at the site on the day of the re-inspection, we parked in the east/west part of the driveway, which turns to the south, and observed a large waste roll-off box in the

north/south part of the continuing driveway, shown in photo # 001. This is a roll-off box that Ms. Spears stated that she provided. We exited the vehicle and initially knocked on the door front. No one answered the door. I then went to the back of the home and knocked on the back door. No one answered there either and no one was observed outside on the property. While leaving the back wooden porch, I observed a burned area in the grass approximately 15' west of the northwest corner of the house, as shown in photo # 002. This area measured approximately 12' x 8' x 1'. Wastes observed included car hoses, paper, cans, landscape wastes, car parts and apparent furniture or car seat springs.

Mr. Jansen and Ms. Laughridge observed the contents of the roll-off box and the area around the garage on-site, while I walked to the west and then southwest of the property to examine areas where wastes were observed during the initial site inspection. I walked to an area at the far western side of the site where a mattress and metals were previously observed. They were still there in a pile measuring approximately 7' x 8' x 2', as shown in photo # 003. Walking further south and back up hill towards the east, wood was again observed in an area measuring approximately 10' x 5' x 1'. Rolled out linoleum was also observed in an area measuring approximately 15' x 4' x 1'. These wastes were observed just west of the apparently vacant double-wide mobile home on-site, as shown in photo # 004. A junk truck that was partially tarped was still present as shown in photo # 005. Additional metals leaned against the truck. Just to the southwest of the junk truck, a previously observed of wastes measuring approximately 5' x 6' x 2', shown in photo # 006. Partially burned PVC pipe, wood, cans, clothes and toys were in that pile. Used tires (eight on-rims and one off-rim), weights, metals, insulation, cardboard and empty paint cans were noted in the area as well, shown in photo # 007.. A pickup truck in that area was observed with a half truck-bed converted into a pull-behind trailer loaded with wastes, shown in photo # 007. Wastes on the trailer included several bags of cans and at least four old car batteries that should be recycled. These are shown in photo # 008.

Walking back towards the apparently unoccupied double-wide, a pile of wastes was found approximately 35' in front of it, as shown in photo # 009. It consisted of cardboard, carpet, toys, general household refuse and measured approximately 9' x 6' x 3'. Closer to the front of that double-wide, a refrigerator was still located on the porch. During the initial site inspection, I was told that the trailer had lost power. Since the refrigerator started to stink due to rotting food, it was dragged outside onto the porch (instead of being emptied and cleaned out, inside). As shown in photo #010, some food was still inside the open refrigerator. A television set and pieces of Styrofoam are shown on the ground. To the northwest of that double-wide, a small pile of framed photographs, a teddy bear and other toys were observed in a pile measuring approximately 6' x 5' x 1' as shown in photo #011. Behind the doublewide trailer and just west of the new garage, an old garage or storage building with a dirt floor was observed, as shown in photo #sa 012, 103 and 014. Photo # 012 shows metals, wood, 16 used tires (eight on-rims and eight off-rims) in a pile measuring approximately 12' x 8' x 2', located just west of the old storage building. In front, or immediately to the south of that building, another pile of wastes measuring approximately 8' x 5' x 2' was observed. It consisted of toys, a truck door, a tire on-rim, wood, and plastics, shown in photo #013. Photo #014 shows

the inside of the old storage building. Its door was found to be open. Wastes on the dirt floor, visible through the open door, include plastics, metals, a bird cage, paper, cans, wood and a toilet. These wastes will also have to be removed. Another toilet was found on the far southern end of the site, adjacent to Lock and Dam Road, also observed during the initial site inspection.

Although some wastes had been cleaned up at this site, a substantial amount of wastes were still present. During the re-inspection, apparent violations of the Illinois Environmental Protection Act (Act) and of the regulations, Title 35, Illinois Administrative Code, Subtitle G (35 IAC), were found to yet exist. Those apparent violations of the Act are Sections: 9(a), 9(c), 21(a), 21(d)(1), 21(d)(2), 21(e), 21(p)(1), 21(p)(3) and 55(a)(1). An apparent violation of the regulations, 35 IAC, is Section: 812.101(a). The Open Dump Inspection Checklist that accompanies this report provides additional information.

#### **Other Comments**

1. The total amount of waste at this site is estimated at 56 cu. yds., down from the 123 cu. yds. observed during the initial inspection calculated as follows:






