



**NOTICE OF WAIVER OF 120-DAY
DECISION DEADLINE FOR AN ADDITIONAL NINETY DAYS**

NOW COMES Petitioner, THE PREMCOR REFINING GROUP INC.

("Petitioner"), by and through its attorneys, HODGE DWYER ZEMAN, pursuant to 35 Ill. Admin. Code § 101.105(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board"), in the above-referenced proceeding, for an additional ninety (90) days, or until October 19, 2005. In support of this Notice, the Petitioner states as follows:

1. On January 13, 2004, Petitioner filed an Appeal of Agency Determination Regarding Request to Modify the Approved Closure Plan sent to Petitioner by the Illinois Environmental Protection Agency ("Illinois EPA") on September 10, 2003.
2. On February 6, 2004, Petitioner filed a Notice of Waiver of 120-day decision deadline for an additional ninety (90) days, or until August 12, 2004. The Board subsequently accepted this waiver.

3. On March 31, 2004, Petitioner filed a Notice of Waiver of 120-day decision deadline for an additional ninety (90) days, or until November 10, 2004. The Board subsequently accepted this waiver, but set the decision deadline for November 4, 2004, due to the Board's meeting being held on that date.

4. On August 5, 2004, Petitioner filed a Notice of Waiver of 120-day decision deadline for an additional ninety (90) days, or until February 2, 2005.

5. On October 8, 2004, Petitioner filed a Notice of Waiver of 120-day decision deadline for an additional ninety (90) days, or until May 3, 2005.

6. On December 28, 2004, Petitioner filed a Notice of Waiver of 120-day decision deadline for an additional ninety (90) days, or until August 1, 2005. The Board subsequently accepted this waiver, but set the decision deadline for July 21, 2005, due to the Board's meeting being held on that date.

7. The parties are currently engaged in discussions that should result in the resolution of this matter. However, these efforts may extend beyond the statutory decision deadline of July 21, 2005.


8. Therefore, Petitioner hereby voluntarily agrees to an additional waiver of the statutory 120-day decision deadline for an additional ninety (90) days, or until October 19, 2005 to provide the parties with an opportunity to resolve this matter without the need for hearing.

WHEREFORE, Petitioner, THE PREMCOR REFINING GROUP INC., prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day

decision deadline for an additional ninety (90) days for final action on Petitioner's Appeal of Agency Determination Regarding Request to Modify the Approved Closure Plan.
