#### ORDER OF THE BOARD:

This matter comes before the Board upon the September 26, 1994 filing of an Administrative Citation pursuant to Section 31.1 of the Illinois Environmental Protection Act (Act) by Sangamon County. A copy of that Administrative Citation is attached hereto, but will not be printed in the Board's Opinion Volumes. Service of the Administrative Citation was made upon Milton Tennant on September 21, 1994. Sangamon County alleges that on July 25, 1994, Milton Tennant, present owner and/or operator of a facility located in Sangamon County and commonly known to the County as Springfield Twp./Tennant, violated Section 21(p)(1) of the Act. The statutory penalty established for this violation is \$500.00 pursuant to Section 42(b)(4) of the Act.

Milton Tennant has not filed a Petition for Review with the Clerk of the Board within 35 days of the date of service as allowed by Section 31.1(d)(2) of the Act. Therefore, pursuant to Section 31.1(d)(1), the Board finds that Milton Tennant, has violated the provision alleged in the Administrative Citation. Since there is one (1) such violation, the total penalty to be imposed is set at \$500.00.

1. It is hereby ordered that, unless the penalty has already been paid, within 30 days of the date of this order Milton Tennant shall, by certified check or money order payable to the Sangamon County Department of Public Health, pay a penalty in the amount of \$500.00, which is to be sent to:

2. Respondent shall include the remittance form and write the case name and number and his social security or federal Employer Identification Number on the certified check or money order.

- 3. Penalties unpaid after the due date shall accrue interest pursuant to Section 42(g) of the Illinois Environmental Protection Act.
- 4. Payment of this penalty does not prevent future prosecution if the violation continues.

IT IS SO ORDERED.

Section 41 of the Environmental Protection Act, (415 ILCS 5/41 (1992)), provides for appeal of final orders of the Board within 35 days. The Rules of the Supreme Court of Illinois establish filing requirements. (See also 35 Ill. Adm. Code 101.246, Motions for Reconsideration.)

#### **JURISDICTION**

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/31.1 (1993), and delegated to Sangamon County pursuant to 415 ILCS 5/4 (r) (1993).

#### **FACTS**

- 1. That the Respondent, **Milton Tennant**, is the present owner and operator of a facility located in the County of Sangamon, State of Illinois.
- 2. That said facility is an open dump, operating without an Illinois Environmental Protection Agency Operating Permit, and designated with Site Code No. 1678220068. Said facility is commonly known to the Agency as Springfield Twp./Tennant.
- 3. That the Respondent, Milton Tennant, has owned and operated said facility at all times pertinent hereto.
- 4. That on July 25, 1994, Allen Alexander, Solid Waste Specialists with the Sangamon County Department of Public Health, inspected the above-described facility. A copy of the inspection report setting forth the results of such inspection is attached hereto and made a part thereof.

#### **VIOLATIONS**

On the basis of the direct observations of Allen Alexander, Sangamon County has determined that the Respondent has caused or allowed open dumping at the above-described facility in a manner which resulted in the following occurrences:

A. That on July 25, 1994, an on-site inspection of said facility disclosed the following:

# Causing or allowing litter (415 ILCS 5/21 (p) (1) (1994)); and CIVIL PENALTY

Pursuant to 415 ILCS 5/42 (b) (4) (1994), the Respondent herein is subject to a civil penalty of five hundred dollars (\$500.00) for each violation specified above in Paragraph A and subpaparagraphs hereunder, for a total of \$500.00. Additionally, should the Respondent elect to petition the Illinois Pollution Control Board under the review process described herein below, and if there is a finding of the violations alleged herein, after an adjudicatory hearing, the Respondent shall be assessed the associated hearing costs incurred by Sangamon County and the Illinois Pollution Control Board, in addition to the five hundred dollar (\$500.00) statutory penalty for each finding of violation.

If you acknowledge the violations cited hereinabove, the civil penalty specified above shall be due and payable no later than thirty five (35) days from the date of service of this Administrative Citation. If you do not petition the Illinois Pollution Control Board for review of this Administrative Citation within the thirty five (35) days, or if you elect to contest this Administrative Citation, any judgment rendered against you shall specify the due date of the statuatory civil penalty and any costs assessed against you.

When payment is made, your check should be made payable to the Sangamon County

Department of Public Health and mailed to the attention of James D. Stone, Director, 200 South

Ninth Street, Room 301, Springfield, Illinois, 62701. Also, please complete and return the
enclosed Remittance Form to assure proper documentation of your payment.

If any civil penalty imposed by the Illinois Pollution Control Board is not paid within the time prescribed in the Order, interest on such penalty shall be assessed for the period from the date payment was due until the date payment was received. If any civil penalty, by reason of acknowledgement, default, or finding after adjudicatory hearing, is not paid when due, either the Office of the Illinois Attorney General or the Office of the Sangamon County State's Attorney shall be requested to initiate proceedings in Circuit Court to collect said civil penalty. In addition to the previously assessed civil penalty, interest and hearing costs of Sangamon County and the Illinois Pollution Control Board, if any, either the Attorney General's Office or the State's Attorney's Office shall seek to recover their costs of litigation.

## PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

You have the right to contest this Administrative Citation. If you elect to contest this Administrative Citation, you must file a Petition for Review with the Clerk of the Illinois Pollution Control Board. A copy of the Petition for Review should be filed with the Sangamon County Department of Public Health. Such Petition for Review must be filed within thirty five (35) days of the date of service of this Administrative Citation, or a default judgment shall be entered by the Pollution Control Board. The Petition for Review must be filed with the Clerk of the Illinois Pollution Control Board at the State of Illinois Center, 100 West Randolph Street, Suite 11-500, Chicago, Illinois, 60601, and a copy of said Petition for Review filed with the

Sangamon County Department of Public Health, 200 South Ninth Street, Room 301, Springfield, Illinois, 62701. The procedure for filing a Petition for Review can be found in 415 ILCS 5/31.1 (1993), and Part 101 of Title 35 of the Illinois Administrative Code.
