
HEARING OFFICER ORDER

The Board meeting immediately before the decision deadline is scheduled for June 15, 2006.

The parties or their legal representatives are directed to participate in a telephonic pre-hearing conference with the hearing officer on March 29, 2006, at 10:00 a.m. The telephonic pre-hearing conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


