

**HEARING OFFICER ORDER**

On May 24, 2006, a telephonic status conference was held. The complainant represented that a revised stipulation and proposal for settlement (stipulation) is being circulated for signatures and that it anticipates that it will file the stipulation within 3 days. It was agreed that respondent's answer is now due on or before July 28, 2006.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 20, 2006, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




