

**HEARING OFFICER ORDER**

On January 25, 2007, all parties participated in a telephonic status conference with the hearing officer. The parties represented that settlement discussions have been ongoing and are at present reviewing draft stipulation and proposal for settlement (stipulation). It appears the parties have a tentative agreement. By agreement, respondents' answer is now due to be filed on or before April 13, 2007.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 29, 2007, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further order.
