Supplemental Affidavit of Steve McNeal in support of TNT's Objection to

Complainants' "Amended Complaint," Motion to Dismiss Complaint as Originally Filed,

and Alternative Motion for Reversal of Hearing Officer's Order ("Objection"), and in

further support of its Objection, states as follows:

- 1. On January 16, 2007, TNT filed its Objection. This Objection objects to and opposes Complainants' filing of a document purporting to be an amended complaint, seeks dismissal of Complainants' original complaint, and alternatively seeks reversal of an order issued by the Hearing Officer in this matter.
- 2. As stated in its Objection, TNT objects to Complainants' "Amended Complaint," and seeks dismissal of Complainants' original Complaint, as frivolous.
