





STIPULATED MOTION TO DISMISS THE CONSOLIDATED ACTION

Complainant the Village of Grayslake (the "*Village*"), by its attorneys, Holland & Knight LLP, and complainants Doris Glave and Glenn Glave (the "*Glaves*") (collectively the "*Co-Complainants*"), move that the Illinois Pollution Control Board (the "*Board*"), through its Hearing Officer, Bradley P. Halloran, dismiss the above-noted consolidated action (the "*Consolidated Action*"), and in support, state:¹

1. On June 6, 2005, Brent Harris, Patty Harris, and the Winds Chant Kennel, Inc. (the "*Respondents*") and the Co-Complainants (collectively the "*Parties*") entered into a settlement agreement (the "*Settlement Agreement*").

2. Pursuant to the Settlement Agreement, Co-Complainants seek to dismiss their claims in this Consolidated Action with prejudice and with each party to bear its own fees, costs, and expenses.

WHEREFORE, Co-Complainants request that the Board, through its Hearing Officer, Bradley P. Halloran, dismiss the Consolidated Action.


