**MOTION FOR EXTENSION OF TIME FOR FILING RECORD  
AND FOR LEAVE TO FILE REDUCED NUMBER OF COPIES**

Respondent THE CITY OF ROCHELLE ("City"), by its attorney, moves for an extension of time in which to file the record in these proceedings, and for leave to file a reduced number of copies of the record, and for leave to file only one set of eleven (11) boxes of copies of correspondence between the Operator and the Illinois Environmental Protection Agency, which was filed as part of the application, and in support thereof alleges:

1. On June 7, 2007, the Board issued its order accepting and consolidating these appeals, and directing the City to file the entire record of its proceedings within 21 days. The Board's order was received by the Rochelle City Clerk on or about June 13, 2007.

2. The City is in the process of preparing the record, but has been unable to complete the preparation of the record despite diligent efforts. The City will be able to complete the preparation of the record and file it on or before July 13, 2007.

3. The hearing is scheduled for July 16-17, 2007. Written discovery is to be completed by June 28, 2007, and depositions, if any, by July 9, 2007. Initial briefs are to be filed by August 1, 2007. The City has filed time certain waivers of the decision deadline to and including October 18, 2007. No party will be prejudiced by the extension of the deadline for filing the record of the City's proceedings to July 13, 2007.

4. Additionally, the City seeks leave to file only the original and two copies of the record. Section 107.304(c) of the Board's procedural rules requires the City to file the original and nine copies of all documents (except the transcript) in the record. The City is aware that the Board has proposed, in rulemaking R04-08, amending its procedural rules to delete the requirement in Section 107.304(c) that the siting authority file the original and nine copies of the record. The City is also aware that the composition of the Board has been reduced from seven members to five members, and that the Board has consolidated its offices. Therefore, the City seeks leave to file the original and two copies of the record.

5. Finally, the City seeks leave to file only the original of eleven (11) banker's boxes of copies of correspondence between the Operator and the Illinois Environmental Protection Agency, which were filed as part of the application, because of their volume.

6. Counsel for the City has contacted the attorneys for all parties and been advised that no parties have any objection to the entry of an order granting this motion.

WHEREFORE, the City seeks an extension of time, to and including July 13, 2007, to file its record; for leave to file the original and two copies of the record; for leave to file only the original of the eleven (11) banker's boxes of correspondence between the Operator and the Illinois Environmental Agency, and for such other relief as the Board deems appropriate.
