REVISED FIGURE 8

Comes now Petitioner Johns Manville, by its attorneys, and hereby files the attached Revised Figure 8, pursuant to discussions at the Hearing on July 19, 2007 in the above-captioned matter. By way of background, Johns Manville's Amended Petition for Adjusted Standard, filed with the Pollution Control Board on September 30, 2004, included Figure 8 entitled "On-Site Landfill—Existing and Proposed GW Monitoring Wells and Proposed Zone of Attenuation". Figure 8 was also referenced in Johns Manville's Proposed Adjusted Standard language for 35 Ill.Adm. Code § 811.318(b)(3):

"In lieu of compliance with 35 Ill.Adm.Code § 811.318(b)(3) as applied to the On-Site Landfill at its facility in Waukegan, Illinois, Johns Manville shall install groundwater monitoring wells at the locations specified on the attached Figure 8. Those monitoring wells located along the proposed Zone of Attenuation boundary shall be considered Applicable Groundwater Quality Standards or "AGQS" wells consistent with the requirements of 35 Ill.Adm. Code § 811.318(b)(5)."


(This Figure was also included in the written Testimony of William Bow that was filed with the Pollution Control Board on June 28, 2007 as Exhibit 2A).

In an order dated July 9, 2007, Hearing Officer Bradley Halloran forwarded questions that members of the Board's Technical Staff would potentially ask at the Hearing on July 19, 2007. One of these areas related to Figure 8 and its depiction of the Zone of Attenuation. The Board suggested that it would be appropriate to revise the

requested adjusted standard so as not to preclude identification of the zone of the attenuation on other sides of the landfill. In his testimony, Mr. Bow presented a Figure that depicted the Zone of Attenuation surrounding Fill Areas 2 and 3, and Johns Manville committed to submit a Revised Figure 8 that more precisely depicted the Zone of Attenuation surrounding the two areas that comprise the On-Site Landfill. That revised Figure 8 is attached.



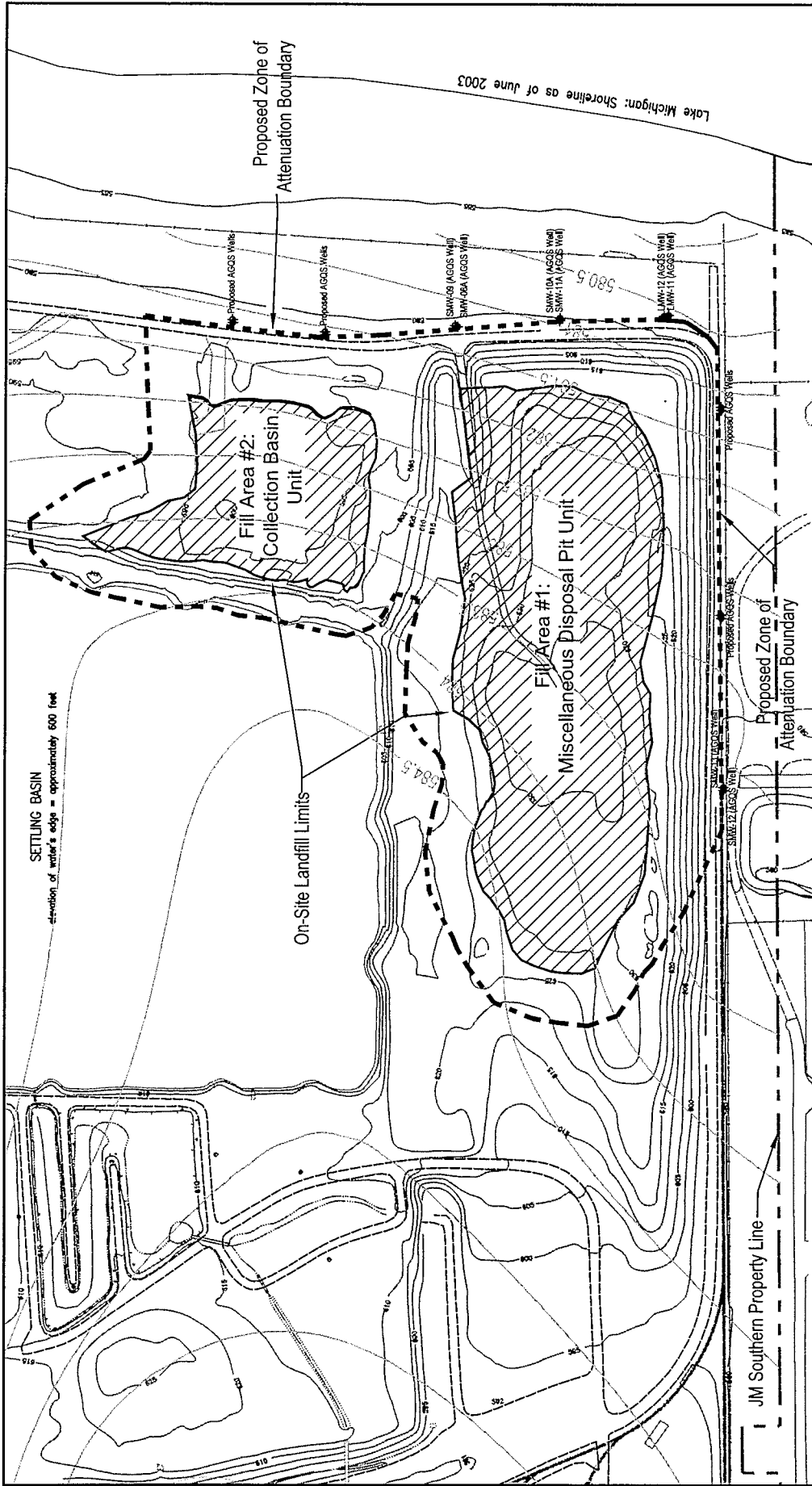

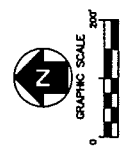
