


NOW COMES the Illinois Environmental Protection Agency ("Illinois EPA") by



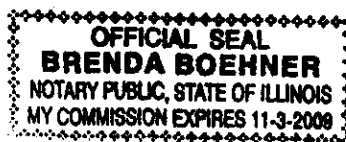
