

HEARING OFFICER ORDER

On September 11, 2008, all parties appeared at a telephonic status conference with the hearing officer. The complainant represented that progress is being achieved in its attempt to narrow the issues, including anticipated remediation efforts by a potential third-party and the “55th sewer issue”. The complainant also represented that the Village of Hinsdale has presented a schedule for the construction application process. It is anticipated that once approved, construction could be completed by March 2009. Complainant continues to review all data forwarded to it from the respective respondents. Both the complainant and respondent DuPage County may seek to add another party to the above-captioned proceedings. Settlement negotiations continue with respondent Metropolitan Water Reclamation District of Greater. It was agreed that the telephonic status conference be continued to the date and time noted below.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 20, 2008, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


