

HEARING OFFICER ORDER

On May 10, 2009, the respondent informed the hearing officer that it had a scheduling conflict for the previously scheduled May 14, 2009, telephonic status conference. The respondent represented that it has reviewed a draft stipulation and proposal for settlement (stipulation) and has commented on it.

If, however, a stipulation is filed prior to the next telephonic status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.



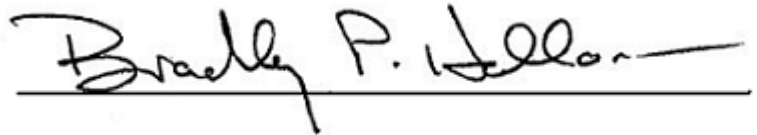
