MOTION FOR EXTENSION OF TIME TO FILE A RESPONSE

NOW COMES Petitioner, SANITARY DISTRICT OF DECATUR (“Petitioner”).

by and through its attorneys, HODGE DWYER & DRIVER, and for its Motion for Extension of Time to File a Response. states as follows:

1. On June 15, 2009, Petitioner filed its Petition for Variance (“Petition”) requesting a variance authorizing continued discharges of nickel and zinc, from its wastewater treatment plant located in Decatur, Macon County, Illinois, into the Sangamon River, pursuant to the terms and conditions outlined in the Petition.

2. On June 18, 2009, the Board accepted the Petition and stated that the Illinois Environmental Protection Agency (“Agency”) “or any person may file an objection to the grant of a variance and request in writing within 21 days of the filing date of the petition, by July 6, 2009 (which is the first business day following the 21st day after the filing date), that the Board conduct a hearing on the petition.” The Board received no such filings.

Electronic Filing - Received, Clerk's Office, September 16, 2009

3. On July 30, 2009, the Agency filed its Recommendation and recommended the Board grant the variance requested by Petitioner, contingent upon the Board including four conditions in the variance.

4. On August 17, 2009, Petitioner requested an additional thirty (30) days from the August 17, 2009 deadline, or until September 16, 2009, to respond to the Recommendation of the Agency, which the Illinois Pollution Control Board ("Board") granted on August 18, 2009.

5. A meeting with the Agency was held on September 9, 2009, to discuss the status of the matter and obtain clarification of the conditions the Agency recommended in its Recommendation.

6. Petitioner is now requesting an extension of time for an additional fourteen (14) days, or until September 30, 2009, to respond to the Recommendation of the Agency.

7. Counsel for the Agency has no objection to the filing of this Motion.

8. For the reasons stated above, Petitioner respectfully moves the Board to grant Petitioner an additional fourteen (14) days from the September 16, 2009 deadline, or until September 30, 2009, to file a Response to the Recommendation of the Agency.

WHEREFORE, Petitioner, SANITARY DISTRICT OF DECATUR, respectfully moves the Illinois Pollution Control Board to grant it an extension of time as set forth above, and to award it all other relief just and proper in the premises.

NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, SANITARY DISTRICT OF DECATUR (“Petitioner”), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until January 7, 2010. In support of this Notice, Petitioner states as follows:

1. On June 15, 2009, Petitioner filed its Petition for Variance (“Petition”) requesting a variance authorizing continued discharges of nickel and zinc, from its wastewater treatment plant located in Decatur, Macon County, Illinois, into the Sangamon River, pursuant to the terms and conditions outlined in the Petition.

2. On June 18, 2009, the Board accepted the Petition and stated that the Illinois Environmental Protection Agency (“Agency”) “or any person may file an objection to the grant of a variance and request in writing within 21 days of the filing date of the petition, by July 6, 2009 (which is the first business day following the 21st day after the filing date), that the Board conduct a hearing on the petition.” The Board received no such filings.

Electronic Filing - Received, Clerk's Office, September 16, 2009

3. On July 30, 2009, the Agency filed its Recommendation and recommended the Board grant the variance requested by Petitioner, contingent upon the Board including four conditions in the variance.

4. On August 17, 2009, Petitioner requested an additional thirty (30) days from the August 17, 2009 deadline, or until September 16, 2009, to respond to the Recommendation of the Agency, which the Board granted on August 18, 2009.

5. A meeting with the Agency was held on September 9, 2009, to discuss the status of the matter and obtain clarification of the conditions the Agency recommended in its Recommendation.

6. The current statutory decision deadline for this matter is December 17, 2009.

7. Petitioner is requesting an extension of time for an additional fourteen (14) days, or until September 30, 2009, to respond to the Recommendation of the Agency.

8. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline until January 7, 2010, in order to file a Response to the Recommendation of the Agency.

WHEREFORE, Petitioner, SANITARY DISTRICT OF DECATUR, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Variance.
