

**HEARING OFFICER ORDER**

On April 22, 2010, the petitioners informed the hearing officer that discussions continue towards a resolve in this matter, including finalizing a host and siting agreement. The petitioners stated that they will file an additional 120-day waiver of the statutory decision deadline.

The parties are directed to participate in a telephonic status conference with the hearing officer on August 26, 2010, at 1:00 p.m. The status must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.


