

HEARING OFFICER ORDER

On May 26, 2010, a telephonic status conference was held with the hearing officer. Respondent Don Swinson did not appear. Complainant represented that a stipulation and proposal for settlement (stipulation) is being circulated for signatures as to respondent Champion Environmental Services. The complainant further stated that a draft stipulation is being discussed with the respondent Swinson. By agreement, the respondents answers are due to be filed on or before August 6, 2010.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on July 22, 2010, at 9:30 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




