#### **REQUEST FOR EXTENSION OF TIME TO FILE RECORD**

Now comes Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by LISA MADIGAN, Attorney General of the State of Illinois, and respectfully requests a thirty (30) extension of time to file the record of Illinois EPA's decision on the permit at issue in this case. In support of its request, Respondent states, as follows.

 Petitioner filed the instant appeal on June 29, 2010. Pursuant to Section 105.116 of the Board's Procedural Rules, Illinois EPA's record of decision was to have been filed by July 29, 2010.
